Grab & Go Meals

Our congregate meal sites have transitioned to a grab & go system during COVID-19. The grab & go program will supply any person 60 and over (plus a spouse of any age) with five (5) frozen meals. All meals meet the Older American's Act Nutrition Guidelines. Donations of \$1.25 per meal are appreciated. If you are not already registered for a congregate meal site, you must call Midland Meals, our meal provider, at 765-477-7189 to register. Midland will help you find the closest congregate location. Home Delivered Meals

Are you unable to leave your home during COVID-19 for fear of the virus? Call West Central's Division of Aging (Area 7) at 812-917-3145 for a short, home delivered meal consultation. Qualifying individuals will have five (5) frozen meals sent to their home during COVID-19.
